The Bylaws of SUMMERGLEN PROPERTY OWNERS ASSOCIATION, INC. are hereby amended as follows:

Article III, Section 3:4 is amended to read as follows:

3:4 Quorum. The presence at the meeting, in person, by absentee or electronic ballot, or by proxy, of Members entitled to cast ten percent (10%) of the votes of each class of membership shall constitute a quorum for authorization of any action, except as may otherwise be provided in the Declaration, the articles of incorporation, or the bylaws. If a quorum is not present at any meeting, the Members entitled to vote thereat shall have power to adjourn and re-convene the meeting from time to time, and at each re-convening of a meeting of the Members, the quorum requirement shall be half of the amount of votes required to establish quorum at the preceding meeting.

The foregoing amendment to the Bylaws of SUMMERGLEN PROPERTY OWNERS ASSOCIATION, INC. was adopted by the Board of Directors of the Association, pursuant to the authority contained in Article XIII of the Bylaws, by majority vote of a quorum of the Board, at a duly-called meeting, as certified by the signatures of the President and Secretary of the Association below.
